Carcinogenicity: [Carbon Black] In 2010, the IARC revaluated carbon black as a GROUP 2B carcinogen (possible

human carcinogen), as it had in 1996. This evaluation is given to carbon black for which there is inadequate evidence in humans, but sufficient evidence in experimental animals. The latter is based upon the development of lung tumors in rat receiving chronic inhalation exposures to free carbon black at level that induce particle overload of the lung. Studies performed in animal models other than rats have not demonstrated an association between carbon black and lung tumors. A two-year cancer bioassay using a typical toner preparation containing carbon black demonstrated no association between toner exposure and tumor development in rats. [Titanium Dioxide] Titanium dioxide is classified as IARC Group 2B. However in lung inhalation testing on rats, mice and hamsters, tumor incidence was only observed with high-dose administration to rats.

Furthermore, a similar trend is seen in rats with inert poorly soluble particles and carcinogenicity is thought to be influenced by the action of the rat-specific immune system. A causal relationship between titanium dioxide and carcinogenicity has not been displayed in human epidemiological

population studies conducted in Europe and North America.

STOT - Multiple Exposure: In a study in rats by chronic inhalation exposure to a typical toner, a mild to moderate degree of

lung fibrosis was observed in 92% of the rats in the concentration (16 mg/m3) exposure group, and a minimal to mild degree of fibrosis was noted in 22% of the animals in the middle (4 mg/m3) exposure group. But no pulmonary changes were reported in the lowest (1 mg/m3) exposure

group, the most relevant level to potential human exposures.
