(Reference 1 - Test Data) In rats, chronic exposure to toner concentrations 4 mg/m <sup>3</sup> and over lead to an accumulation of particles in the lung as well as to persistent inflammatory processes and slight to moderate fibrotic changes in the lungs of rats. In hamsters, these effects were only observed at significantly higher concentrations (> 20 mg/m <sup>3</sup> ). The particle accumulation in the lung tissue of the experimental animals is attributed to a damage and overload of the lung clearance mechanisms and is called "lung overloading". This is not an effect specific to toner dust but is generally observed when high concentrations of other, slightly soluble dusts are inhaled. The lowest-observable-effect-level (LOEL) was 4 mg/m <sup>3</sup> and the no-observable-effect-level (NOEL) was 1 mg/m <sup>3</sup> in rats. The NOEL was greater than 6 mg/m <sup>3</sup> in hamsters. (Reference 2 - Test Data) Toner concentration under the normal use of this product is estimated to be less than 1 mg/m <sup>3</sup> .
